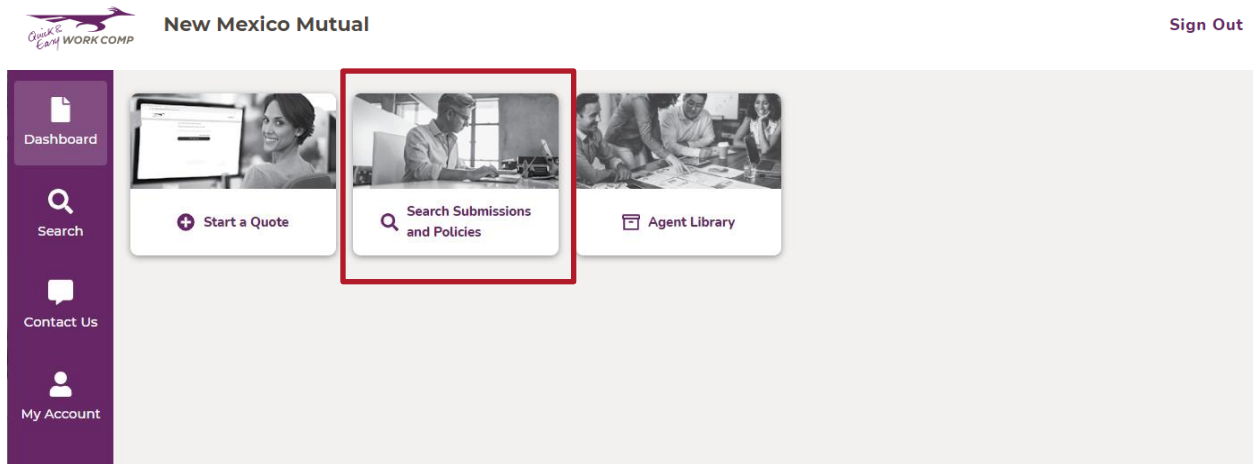


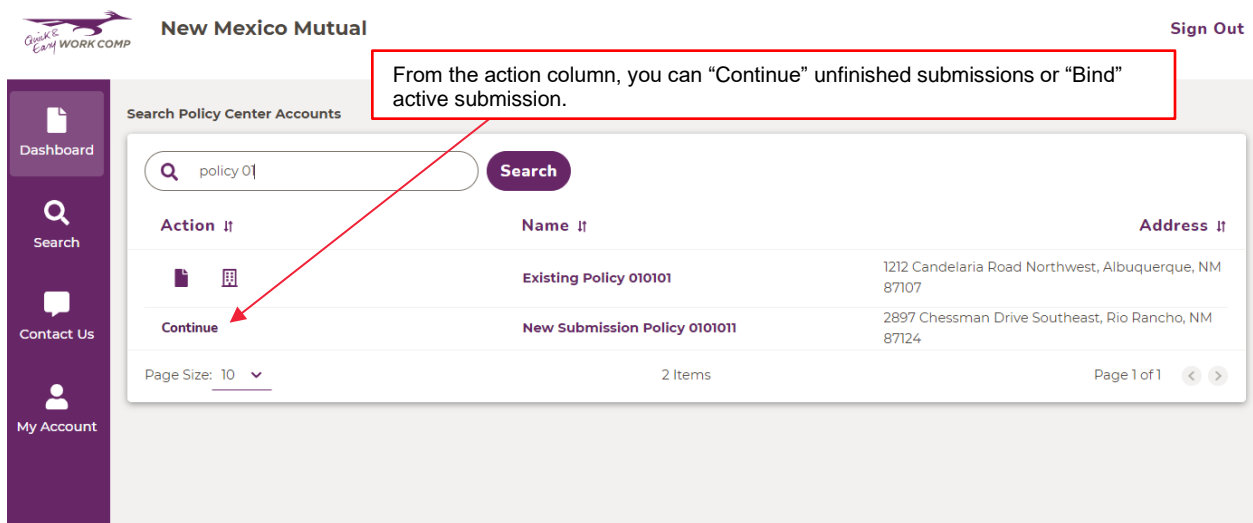
SEARCHING ROADRUNNER

Search for Roadrunner Submissions and Existing PolicyCenter accounts.

The link to PolicyCenter has been replaced with a single search function that lets you search for both new submissions created through Roadrunner and all existing accounts.




This search function pulls existing accounts and policies along with submissions created through Roadrunner. You can search by Account Name, Account Number, Policy Number, and Submission Number.



In the screenshot above, the search returned 2 results: an existing policy with links under the action column to view the documents in Roadrunner, and a second link that redirects to the PolicyCenter account.

Accessing existing PolicyCenter accounts is easy! Simply use the single search function to find the account by account name, account number, or policy number, and click the link to PolicyCenter.




