# **Position Summary:**

The Senior Counsel is an experienced attorney and trusted advisor proficient in litigation and appellate work. Senior Counsel's primary responsibilities are to provide complex legal services to the company's subsidiary, Integrion Group, Inc., in administering the Patient-Compensation Fund (PCF). These services include advising the PCF Custodian and administrator on general fund administration issues; filing and prosecuting complaints for intervention, declaratory judgement or other legal proceedings to protect the PCF; filing or defending appeals impacting or involving the PCF; and managing outside counsel in these efforts as needed. Senior Counsel will also work with the Vice President and General Counsel to perform legal research and provide general counsel on corporate compliance, regulatory matters, IPRA, and other areas affecting the company, its subsidiaries, and partners.

# **Essential Functions:**

- File or defend litigation and appeals impacting the PCF and Medical Malpractice Act ("MMA")
- Advise clients on litigation strategy, claims, and settlement evaluation
- Oversee outside counsel as necessary to meet litigation demands and execute legal strategy
- Attend and participate in rate and rule hearings, legal hearings, and mediations
- Analyze proposed legislation and provide analysis of impact on the company and its partners
- Evaluate requests for settlement authority for medical malpractice claims
- Respond to legal process and requests, including subpoenas and records requests
- Perform legal research and writing to identify risks and advise on novel and emerging issues
- Draft and prepare legal documents, negotiate and review settlement and other commercial agreements and support the contract administration process
- Partner with the Vice President and General Counsel on other legal and compliance matters as needed
